Your views on Renfrewshire IJB's Budget

Renfrewshire Integration Joint Board (IJB) is responsible for planning and overseeing social care and health services for adults, and health services for children, across Renfrewshire. This includes making decisions about what services are delivered and how available budgets are spent. On behalf of the IJB, Renfrewshire Health and Social Care Partnership delivers these services. Against a backdrop of financial challenges, and to enable a balanced budget to be set in 2025/26, Renfrewshire IJB will have to consider a range of options:

- Reducing, changing or stopping some of the services we provide.
- Using technology better and more frequently.
- Using property differently.
- Looking at different approaches to delivering our services.

It is important that we gather a range of views, and we are therefore seeking your feedback on how acceptable changes like this would be to you. This is an anonymous and voluntary survey. However, if you would like us to contact you directly there is an opportunity for you to give us your details within the survey.

How we will use the information you provide

Although the survey is anonymous, should you choose to provide your contact details this will be personal information. Any personal information collected will be processed in accordance with UK GDPR ("General Data Protection Regulation") and the Data protection Act 2018. It will be used only for the purposes of contacting you.

The survey has been developed in line with Renfrewshire Council and the IJB's public functions. This includes making decisions around savings, strategic planning, and budget and transformation programmes. We might also use data you provide for research purposes. An analysis of responses provided will be used to inform the development of savings options and reports for the IJB's consideration and may also be included in reports submitted to Renfrewshire Council and NHS Greater Glasgow and Clyde.
